GDPR INFORMATION CLAUSE

Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ EU L 119, p. 1) – hereinafter referred to as the GDPR, effective from May 25, 2018, hereby informs:

1. The Administrator of your personal data is the MATHEMATICAL INSTITUTE OF THE POLISH ACADEMY OF SCIENCES, with its registered office in Warsaw (00-656), ul. Jana i Jędrzeja Śniadeckich 8 (hereinafter referred to as: IM PAN).
2. The Data Protection Officer is Mr. Marcin Bąk. The Officer can be contacted via email at iod@impan.pl or by phone at 601-141-527.
3. Your personal data will be processed for the purposes of recruitment conducted as part of competitive procedures, including for the purpose of contacting applicants and for the time necessary to conduct and complete the competitive procedure – on the basis of the actions of applicants before the results of the competition are announced and to the extent necessary to conduct the competition (Article 6(1)(b) of the GDPR), on the basis of the consent of the persons applying for the competition (Article 6(1)(a) of the GDPR), and in order to fulfill the legal obligation incumbent on the Controller (Article 6(1)(c) of the GDPR), in connection with the Controller's activities as an Institute of the Polish Academy of Sciences.
4. The recipients of your personal data will only be entities authorized to obtain personal data on the basis of legal provisions and authorizations granted by the Administrator for the purpose of conducting the competition properly.
5. Your personal data will be stored until the end of the recruitment.
6. The administrator kindly informs you that you have the right to: request access to personal data; rectify personal data; delete personal data – with the exception of data provided and processed during periods required by law; restrict the processing of personal data; object to the processing of personal data; withdraw consent at any time by emailing iod@impan.pl, however, withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal; lodge a complaint with the supervisory authority. In order to exercise the rights set out above, please contact the Administrator or Data Protection Officer.
7. Providing personal data is voluntary, but failure to provide such data may result in the inability to participate in the recruitment.
